Upcoming Webinar: Behind the Scenes of Form I-17 Updates

Join SEVP for the next Ask the Experts Webinar on July 27, 2017 from 2 to 3 p.m. EDT. This webinar will take an in-depth look at the Form I-17, "Petition for Approval of School for Attendance by Nonimmigrant Student," updates process and include a live question and answer session with SEVP representatives.

Understanding the Legal Implications of the Form I-17

Designated school officials (DSOs) have several important responsibilities when working with international students. When SEVP adjudicates a school's completed, signed Form I-17, the school and DSOs officially enter a legally binding commitment with the federal government.

Submitting and signing the Form I-17 and agreeing to the school official compliance agreement in the Student and Exchange Visitor Information System (SEVIS) means that a school and its officials agree to comply with applicable federal regulations, U.S. Department of Homeland Security requirements and reporting obligations.
